The inspection

Plan of inspection

This inspection was executed based upon article 1.62, section 1 of the Dutch Childcare Law. It concerns an announced inspection for registration.

It concerns **a change of holder**. A research has taken place based upon documents.

Vision

Holder Zo Unltd B.V. has filed a request for a change of registration in the LRK (National Registration of Daycare centers) at the township of The Hague on 04-24-2018. The change concerns a change of holder.

The past year a regular inspection visit took place on 11-16-2017. During this inspection visit several trespasses have been noted.

On 03-23-2018 a conversation took place on account of these noted trespasses, between holder and location manager, the legal expert of the department of Education of the city the Hague, and the inspector.

During this conversation holder stated that the majority of the noted trespasses had been solved by then, and that appropriate action has been taken to end the remaining trespasses. Prolonging of exploitation will most likely take place in accordance with the noted or in virtue of paragraphs 2 and 3, section 3, Dutch Childcare Law.

During the next inspection visit the remaining items will be judged.

Advice to City Council

Include in the national registration of childcare.

Observations and findings

Declaration regarding behavior (VOG) and registration of people in childcare (PRK)

Employees in childcare must own a Declaration Regarding Behavior (VOG). A VOG shows that a person does not have any criminal record in his/her name which may form an obstacle while working in childcare.

All professional employees working in childcare are under continuous screening.

Continuous screening means that the Judicial Documentation System is checked daily to see if people working in childcare or preschool do not have any new criminal record to their name.

The inspector has judged the declaration regarding behavior (VOG) in the registration of people in childcare (PRK) of the holder of this childcare center.

This declaration regarding behavior has been approved of on 04-05-2018 and linked in the registration of people working in childcare on 04-06-2018.

All other declarations regarding behavior will be judged during the next inspection visit.

<p>In possession of a declaration regarding behavior are:</p> <ol style="list-style-type: none">a. Holder or intended holder of a childcare center;b. People who work or will be working, based on an employment contract with holder or an employment agency, during opening hours at the location of an enterprise with which holder exploits a childcare center and where children are cared for;c. People who work or will be working, based on a different contract with holder, structurally during opening hours at the location with which holder exploits a childcare center and where children are cared for;d. People who, on account of their position, have or will have access to information regarding the children who are cared for;e. People, of 18 years and older, who have or will have their main residence at the street address where a childcare center is located, or those who will or will be structurally present during opening hours at the childcare center, located at the street address. <p>As far as it concerns persons, each and every one, as intended in parts a to e, is submitted in the registration of people working in childcare, as intended in article 1.48d of the Dutch childcare law.</p> <p>The declaration regarding behavior will not be older than two months when submitted to the registration of people working in childcare.</p> <p>For people who on 02-28-2018 are continuously screened based on the articles 9a and 9b of the Decree national registration childcare and registration foreign childcare (as that applies to 02-28-2018) a transitional provision is in order and the Minister will submit the data in the registration of people working in childcare in the period of 03-01-2018 till 07-01-2018. (art. 1.50 paragraph 3 Dutch Childcare Law; art 17.d Dutch childcare Law; art 18a Decree national registration childcare, registration foreign childcare and registration people working in childcare)</p>
